It was on the 23rd of March that the redeeming Whatsapp message arrived from the Colombian National land agency (Agencia Nacional de Tierras - ANT) saying that the directive committee, where different governmental organisations are part of, had aproved the application of San Martin and Pameras. In the history of the Ticuna Cocama and Yagua indigenous reserve this is the second enlargement with exactly 30.757 hectares and 9.847 m² (Globo 2 on the landmap on the next page). The first enlargement of 54.000 hectares in 2003 came relatively fast after the foundation of the reserve in 1999 (87.000 hectares). In total the reserve nowadays consists of about 173.000 hectares of rainforest in very good state. A small part consists of active agriculture fields and regrowth forest.


The territory of the five communities around Puerto Nariño (Ticoya, Patrullero, Veinte de Julio, Puerto Esperanza and Valencia) covers 1.617 hectares and 324m² (the blue circle on the map) and is still being lobbied and discussed. It is still impossible to estimate how much time is still needed before these lands are also recognised as part of the TICOYA reserve. At the moment these lands are no mans lands and there is a risk of these lands being occupied by third parties, which has already happened in some places. After five years these third parties receive the right over their lands. There are already meetings taking place with these new owners. Also the municipality of Puerto Nariño is trying to get it's hands on the lands in order to expand it's urban area. It's a process in development and we will keep updating you about it via our newsletters.

We would like to pause for a moment and think about how unique it is that in a land like Colombia there is the right of recognition of ancestral lands, as a indigenous reserve where the inhabitants are politically authonomous. Looking from this perspective one could think that some more developed countries are far behind. What a luxury is the recognition of this wonderful rainforest in these times of land



grabbing, legal and illegal mining and invasions of settlers for logging, livestock farming, cocaplantages, cocain production, commercial fishery and religious cults. Despite the declining fish stocks in general in the Amazon (probably due to the overfishing in the big cities?) the population of the TICOYA indigenous reserve is still able to live from fishery, hunting and traditional agriculture.

The recognition has been an extra boost for the environmental patrol who has been managing the territory with so much dedication. The received political authonomy also indicates the total responsibility to take care of the reserve. Also on this matter we will keep you posted!

WONE MEETING TICOYA

On the 26th, 27th and 28th of April the most important meeting of the TICOYA reserve took place. All communities of the reserve gather at this event in order to discuss important themes. A so called Wone meeting takes place every 18-24 months and it's name derives from the "Wone" tree out of which (after a very long story) the Amazon was created. This year it was, of course, the time to talk about the

recognition of the ancestral lands. It was important to discuss this topic since there were already some rumours spreading that all the five communities had already been recognised, which is not true. This had to be cleared up. Also the representatives of San Martin held a speech in which they explained about their future job as the organisers of the freshly recognised territory.
