SMALL WORLD MEETING

With lots of attention the expenses were discussed: To what extend did the different activities contribute to the main goal of the Small World Foundation (recognition and protection of the ancestral territory of San Martin de Amacayacu)? Why was and is it so important to participate in specific events and meetings organized by several institutions (National Parks, governments, indigenous organizations and communities) and at different political levels (local, regional, and national)? What has been paid during those meetings or participations?

IMPORTANT DOCUMENTS READY!

When the 74th newsletter was written, the National Land Agency (ANT) asked for one more document: A declaration of San Martin de Amacayacu and Palmeras to officially renounce from the indigenous reserve of Ticuna Cocama and Yagua (TICOYA). As a consequence, these communities will represent the hopefully soon to be established indigenous reserve and will receive the government subsidy separately from the TICOYA reserve.

The ANT also asked for an official approval of the renunciation by the legal representative of the TICOYA reserve and of the mayor of Puerto Nariño.

Eventually the habitants of San Martin and Palmeras came together on the 11th of September to sign the declaration. The general impression of the meeting was that the people were more or less bored: The participants made it clear they have had enough of having to fulfill all kinds of requirements all the time. In the month after the meeting it cost a lot of effort to receive the letters of approval from the TICOYA reserve and the municipality of

Puerto Nariño. Mid October they were finally ready! All the paperwork was directly sent to the ANT and the other concerned organizations. Now, all we can do is patiently wait...Exciting!
